### SUBCONTRACTOR LICENSING REQUIREMENTS

#### Applicants must provide the following before a license can be issued:

- 1. Completed and signed subcontractor license application.
- 2. Photocopy of current license held in a Mississippi municipality.
- 3. Letter from City where licensed. Letter must state that license has been held for at least one year in good standing.
- 4. License Bond (\$5,000). We must receive "Original" copy from insurance company.
- 5. Certificate of General Liability Insurance (Minimum \$300,000 each occurance).
- 6. Applicant must present photo ID in person.
- 7. \$25.00 fee

NOTE: There is a \$25.00 charge per license issued. However, if contractor holds a current State Certificate of Responsibility from the State Board of Contractors, the fee is waived when a copy of this certificate is received in our office. Only the person that took the State exam can have his/her fee waived.

#### REQUIREMENTS FOR \$5,000 SUBCONTRACTOR'S BOND

The following requirements must be met before filing a bond with the City of Ridgeland, Mississippi.

- (1) Bonds have to be signed where it says "Resident Mississippi Agent" and "Attorney-in-Fact".
- (2) Bonds must be executed on forms furnished by the City of Ridgeland.
- Original copy of bond must be signed and filed with the Building Permit Division of the City of Ridgeland.
- (4) Surety Power of Attorney and Seal must be affixed to the bond and Corporate Seal.
- (5) The General bond must be in the individual's name or the individual doing business as a corporation or company. We do not bond companies. If it is written as a corporation, an officer of the corporation must sign the bond and show his title. Thirty (30) days written notice is required to be given to the city prior to cancellation or non-renewal of above.
- (6) All electrical, plumbing, mechanical, residential electrician and gas pipe fitter contractors must have bonds in their names doing business as a company, or as an individual. Bonds must be in the name of the person who passed the examination and qualified for license.
- (7) Electrical, plumbing, mechanical, residential electrician and gas pipe fitter contractors must furnish a Certificate of General Liability Insurance along with the Contractor's Bond. Minimum coverage is \$100,000, \$300,000 and \$5,000. Thirty (30) days written notice is required to be given to the City prior to cancellation or non-renewal of above.
- (8) Contractor's mailing address and telephone (local) number must be on the bond.
- (9) If a representative is to take out permits, a letter of authorization giving a Limited Power of Attorney must be drawn up by an attorney and on file in the Community Development office.
