GETTING STARTED City regulations require that you obtain a Garage Sale Permit prior to your garage sale. The permit can be obtained at City Hall, Community Development Department between 8:00 AM and 5:00PM Monday through Friday. Cost of the permit is \$2.50. Don't forget to display your permit during your sale? Garage sales are permitted no more than two (2) times per calendar year. ADVERTISING YOUR SALE Although newspaper advertisements are the most popular means of publicity for your garage sale, many people choose to post signs announcing their sale. According to the city ordinance no sign shall be posted on public right-of-way, traffic signs, telephone polls and trees. There may be one sign posted on the lot where the garage sale is taking place. You are allowed two (2) off premises garage sale signs; however, a permit must be obtained for these signs along with a Statement of Understanding from the property owner giving permission to place this sign on his/her property. The dimensions of this sign shall not exceed six square feet and must be removed at the conclusion of the sale, in no case shall the said sign be erected for a period of more than seven days.
